

**RENEWAL AND AMENDMENT OF THE  
MASTER AGREEMENT FOR COMPUTER ASSISTED LEGAL RESEARCH  
(THOMSON WEST)**

**I. PURPOSE**

Under the Assignment, Renewal, and Amendment of Master Agreement for Computer Assisted Legal Research effective August 31, 2001, The State Law Library ("Library") accepted the assignment of the Office of Court Administration's ("OCA") rights, interests and obligations under the Master Agreement (the "contract") dated June 27, 2000 entered into between OCA and the WEST GROUP, now known as THOMSON WEST ("West") for the provision of computer assisted legal research. The Library and West do hereby agree to renew and amend the contract, as follows:

**II. RENEWAL OF THE CONTRACT**

Pursuant to the "Term of Contract" provision of the Master Agreement, the Library renews and extends the contract as amended for the following term: September 1, 2006 to August 31, 2007 (the "contract renewal period") unless terminated earlier in accordance with the terms of the contract.

**III. AMENDMENT TO THE CONTRACT**

The definition of "judicial entities" in the "Purpose of the Contract" provision of the Master Agreement is hereby amended to include "assigned judges." For purposes of this contract an "assigned judge" is a judge who is eligible to serve on assignment under Sec. 74.003 or Sec. 74.055 of the Texas Government Code. Assigned judges are eligible for the rates provided under the contract so long as the judge's use of the Lexis product is for the purpose of fulfilling the judge's duties as an assigned judge. "Assigned judge" pricing will be the same as that provided for judges.

The Library and West understand and agree that: (1) all of the provisions of the Assignment, Renewal and Amendment of the Master Agreement effective August 31, 2001 will remain in effect unless specifically addressed in this amendment; and (2) all of the other provisions of the original master agreement remain in effect.
